- Responsible for the development and implementation of Asset Management Plans and related projects to support the sustainable management of the Region's water, wastewater, waste management, forestry and energy assets.
- Provides input to Corporate Asset Management initiatives by seeking and providing subject area expertise.
- Leads the development of asset management frameworks for various asset classes or service areas.
- Establishes Levels of Service (LOS) and KPI indicators, determines data requirements, undertakes gap analysis, and initiates process to collect required data.
- Reviews and analyzes system performance, conducts risk analysis, and identifies areas for improvement.
- Plans, develops, and coordinates infrastructure inspection and data collection programs to support condition assessment/rating, lifecycle analysis, and the prevention of infrastructure degradation.
- Ensures quality assurance activities to monitor program effectiveness and support continuous improvement efforts with the business unit to ensure consistency and adherence to standards.
- Oversees the development and maintenance of procedures, guidelines and templates related to infrastructure management, improvement and maintenance.
- Oversees engineering consultants in the completion of studies and projects, relevant to the long-term planning and sustainable management of departmental assets.
- Liaises with and maintains positive relationships with internal Department contacts, crossdepartment staff, external contractors, consultants, government and non-government agencies and the public, as required.
