Reporting to the Chief Materials Inspector, or designate, be responsible for providing technical evaluation and quality control of all construction materials and methods used on City contracts.

Responsibilities

- Conducting site inspections and pedological (soils) surveys and tests for the construction and design of new roads, subdivision services and reconstruction of existing roads
- · Conducting specified tests on asphalt, soils, aggregates and concrete
- Conducting special investigations and preparing reports on various constructionrelated subjects
- Investigating, handling and responding to complaints related to construction
- Providing assistance and advice to construction field personnel
- Maintaining quality assurance checks on consultants' work related to soils analysis, granular and asphalt analysis and compaction results
- Setting up and maintaining a comprehensive inventory filing system
- Providing and performing various other services related to the materials inspection function
