Reporting to the Manager, Infrastructure and Asset Management Planning, the Infrastructure Planning Engineering coordinates the development of the department's annual capital budget and 10-year forecast and coordinates the evaluation, assessment and rehabilitation strategies for the department's asset categories through the creation, management and implementation of individual Asset Management Plans (AMPs).

## Job Responsibilities:

- Coordinates the development of the department's annual capital budget and 10-year forecast including confirming project scopes, cost estimates, implementation strategies and schedules.
- Liaisons with department staff, town departments, other municipalities and agencies for the development of the annual capital budget and 10-year forecast, including chairing coordination meetings.
- Completes audits of completed capital construction projects to assist with scoping and cost estimating of future projects and assists with capitalization of completed capital construction projects.
- Coordinates the evaluation, assessment and rehabilitation strategies for the department asset categories including pavement, bridges, culverts, storm sewers, sidewalks, pathways, retaining walls and noise walls.
- Creates, manages and implements individual Asset Management Plans (AMPs).
- Performs infrastructure inspections and assessments and oversees consultant infrastructure inspections and assessments.
- Develops scope of work for consultant assignments for the completion of infrastructure assessments for all asset categories (pavement, bridges, culverts, storm sewers, sidewalks, pathways, retaining walls, noise walls).
- Oversees the entry and maintenance of all asset maintenance data into the Infrastructure Management System (IMS).
- Confirms rehabilitation and implementation strategies for department assets including capital projects and maintenance programs.
- Provides technical support and expertise towards the development, implementation, operation and maintenance of all modules within the Infrastructure Management System (IMS).
- Provides professional and technical support to staff reviewing municipal consents.
- Provides professional and technical support in the delivery of capital projects.
- Represents the town as part of municipal infrastructure projects from other agencies such as Region of Halton, Ministry of Transportation, Metrolinx, utilities, etc...
- Coordinates the review of engineering drawings for external projects.

#### **Qualifications/Skills:**

- Registered as a licensed Professional Engineer in good standing with the Association of Professional Engineers of Ontario (PEO).
- Minimum 5 years of working experience as a licensed Professional Engineer.
- Thorough knowledge of municipal infrastructure assets (pavement, bridges, culverts, storm sewers, sidewalks, pathways) including design, construction, rehabilitation and condition assessment.
- Budgeting and finance knowledge and skills to develop the 10-year Capital Program including project scoping, costing, financing and prioritization.

- Computer literacy utilizing MS Office software applications and database management techniques as well as GIS, Arcview, ArcInfo, AMANDA and CAD.
