# What am I talking about?

- A new digital permitting platform made **by municipalities for municipalities**
  - Funded through the *Ministry of Municipal Affairs and Housing*
    - Powered by Transnomis
- Project Goal: Make Life Easier
  - Easier for: Municipal staff to review and issue permits
  - Easier for: Transport companies to get the right permits
  - Easier for: Developers and utility companies to apply for permits in the right municipality
  - Easier for: Residents to work with their municipalities

# Who am I

- County Engineer for the United Counties of Stormont, Dundas and Glengarry
  - Only the 4<sup>th</sup> County Engineer in 104 years
  - One of the largest County Road networks in Ontario (~980 km)
  - Largely 'rural' roads



# About SDG

- In 2021 SDG issued 644 moving permits
  - Widest move in 2021: 10.06m (House)
  - Longest move in 2021: 75m (246') (Blade)
  - Heaviest move in 2021: 114,450 kg (Transformer)




# About SDG

- Annually Issue > 300 other permits
  - 60 Entrance
  - 20 Road Cut
  - 150 Municipal Consent
  - 10 Special Event
  - 30 Sign



# One Window Permit Initiative



- 2020 Eastern Ontario Leadership Council study became a proof of concept
- Helped to justify larger “One Window” project funding request to MMAH

# Permit Types and Scope

- Oversize/Overweight Load - Trip
  - Oversize/Overweight Load - Annual
  - Road Entrance
  - Municipal Consent
  - Event in Right-of-Way (includes film)
  - Work in Right-of-Way
  - Private Sign in Right-of-Way
  - Private Sign adjacent to Right-of-Way
- *Custom permits options will be available*

## 11.3. Permit Details

1. "Start Date\*" (pick date)
2. "End Date\*" (pick date)
3. "Load Dimension(s) and Weight(s)\*" (table)
  - Help text: "Use one row per load. Only enter the dimensions that exceed HTA (width 2.6m, height 4.3m, length 12.5m, combo-length 23m, rear overhang 4.65m, weight in kg (if load and or axle weights exceed HTA, enter weight here, and upload axle table(s))."
4. "Is the load considered hazardous waste?\*" (check box)
  - Help text: "If yes, upload MOE certificate below."
5. "Load details overview (e.g., cargo, vehicle type, origin, destination)" (text)
  - Help text: Provide sufficient detail for authorities to identify load on the road, and where it came from and is going so that we might identify an alternate route if needed.
6. "Hauling unit(s) license plate(s) and name on door" (text)
  - Help text: "If required, enter license plate numbers for the hauling unit(s) to be used with this permit. Some road authorities require further details or cab cards uploaded below."
7. "Trailer license plates" (text)
  - Help text: "If required, enter license plate numbers for any trailers that may be associated with this permit."
8. "Is this trip subject to Ministry of Transportation (MTO) or Ministry of Environment (MOE) permits?\*" (check box)
9. "List associated MTO and MOE permit numbers"
  - Help text: "Some road authorities require MTO and MOE certificates be uploaded below." (text)
10. "Insurance Expiry Date\*"
  - Help text: "Certificate(s) to be uploaded below.\*" (date)
11. "Additional information" (text)
  - Help text: "See road authority conditions for additional information that may be required."
12. "Applicant reference"
  - Help text: "This field supports the addition of your internal reference for this application."
13. "Route" (draw route)

1. "Insurance Certificate(s)\*"
  - a Help text: "See road authority's conditions"
2. "Axle table(s)"
  - a Help text: "Required if weight exceeds HTA"

# The Applicant's Perspective

## Single Move Permit Application

Required when performing one move only within a short time frame (up to 3 days)

- \$70.00 (with 48 business hours notice)
- \$100.00 (without 48 business hours notice)

## Annual Moving Permit Application

Recommended when frequently moving over-dimensional loads in SDG. This permit is limited to certain dimensions and weights (listed on application) and is valid for one calendar year.

- \$280.00 for first tractor plus \$30.00 for each additional tractor.

## Load Dimension(s) and Weight(s) \*





- Single application to multiple jurisdictions
  - Just draw the route on a map


# The Applicant's Perspective



- Integrates with Municipal511
  - Can see truck routes, construction activity, road restrictions, closures etc....

# The Applicant's Perspective

- Approved Permits include map image and QR Link
  - Allows truckers to review route
  - MTO Inspectors can see approved route





# The Applicant's Perspective

- Best Practice: Compound Permits
  - Municipal Consent, Entrance, Event in ROW, Sign in ROW
  - Separates (but links) the “Engineering” from the “ROW Disturbance”
- How:
  1. Applicant applies for the ‘technical’ approval
  2. Road Authority approves the ‘location’
  3. Contractor later applies for linked “Work in Right of Way Permit”

**Start Work**

**End Work**

**Pause Work**



# The “Approver” Perspective


- Flexibility!
  - Enable/disable the permit type
  - Identify required fields, e.g., MTO certificates required
  - Have non-required fields hidden
  - Customize auto and semi-automated email templates
  - Identify staff notified for new permits
  - Identify staff/people that may process, view only, be consulted
  - Add default text for certificates
  - Upload jurisdiction conditions
  - Set permit expiry notification period
  - Insert price(s)
  - Select payment method used
  - Use auto approve, e.g., OO Annual


# Two-Tiered Municipalities



- Jurisdictions without Platform
  - Communicate from permit service
  - Consulted login and add yes or no, comments
- Examples:
  - Oversize load that ends on local road
  - Road cut across County Road and Local Sidewalk

  - Provide comments back, request revisions etc....



- Auto Approve Option for Annual Moves
  - Receipt of Payment = Issuance of Certificate

## **Oversize/Overweight Annual Permit (OO Annual)**

An Oversize/Overweight Annual Permit (O/O Annual) relates to multiple oversize/overweight loads that exceed the Highway Traffic Act, using one or more hauling units, during a calendar year. Each load is subject maximum weights and dimensions, as well as seasonal and specific load restrictions (e.g., bridge).

  - May be logged in system after permit has been issued





# The “Approver” Perspective

- Much better interface than current practice
- Integrates with **up to the moment** road information on Municipal511
- Time saver for the applicant and approver
- Affordable pricing model that can be passed through to applicants
