

General Conditions Committee is responsible for reviewing and revising the General Conditions of Contract.

OPSS.MUNI 100

Why use Muni 100

- A tool for contract administration.
- Represented by Municipal/Ministry (MEA, MTO) and industry partners(ORBA, OSWCA, ACEC)
- Provides consistency
 – builds reliability among construction partners
- Minimize municipal risk exposure by using accepted and tested contract administration methodologies
- Aligns with the Construction Act

BRIEF OVERVIEW OF OPSS.MUNI 100

GC 1.0

Interpretations

Provides a definitions and interpretations of the terminology used in the document.



Administration of the Contract

Provides overall contract administration measures e.g. extension of time, delay, claims procedure, change orders.



Contract Documents

Provides Order of Precedence of the documents as to which document governs should there be a discrepancy



Owner's Responsibilities and Rights

Stipulates what the owner can or cannot do

GC 5.0

Material

Roles and responsibilities of the owner and the contractor as it relates to material handling for the work



Insurance, Protection and

Damage

Identifies types of insurances and bonds available to protect the owner and the affected parties.



Contractor's Responsibilities and Control of the Work

Identifies contractor's responsibilities in managing the work site



Measurement and Payment

Deals with certification of work, contract payments, proper invoices, time and material work, release of holdbacks, warranty, liquidated damages etc.

UPATES TO OPSS.MUNI 100- NOV 2024 CIATION

Sub-Clause	Page No.	Change
8.02.05.08.02	57	Revised the last sentence in sub-clause to read "If Work on a Time and Material Basis is assigned or sublet to a related entity or associated corporation with common ownership to the Contractor as defined by the Securities Act, RSO 1990, cS.5, then the Contractor markup is not permitted."
8.02.05.09.03	57	The word "contract" is capitalized.
8.02.05.11	58	Changed "Work" to "Work on a Time and Material Basis" at 3 instances within the sub-clause.





- The Committee will continue with the next 5-year review cycle starting from 2024 to 2029.
- The next revision of OPSS.MUNI can be expected in November 2029.
