MECP Amends O. reg. 406/10: On-Site & Excess Soil Regulation

The Ministry of the Environment, Conservation & Parks (MECP) has finalized an amendment to O. Reg. 406/19: On-Site & Excess Soil Regulation.

MECP announced they have taken feedback into consideration on proposed amendments described in ERO 019-9196, and is updating the Excess Soil Regulation to change the in-effect date of a provision preventing the landfilling of cleaner soil by two years and to clarify the exemptions to this provision.



MCEA REFORM


The MECP advised MEA earlier in 2024 that it intends to revoke the current Municipal Class EA and replace it with a new regulation (Municipal Project Assessment Process – MPAP). To date, MECP has not provided any timeline on when this will occur.

MCEA USER GUIDE

While the MECP is planning to revoke the MCEA, until the new MPAP Regulation is approved, the current MCEA process still applies. The MEA continues to offer its *MCEA User Guide (September 2023)* publication for proponents. It is currently available for purchase in hard copy format only.

<u>Municipal Class EA</u>

MEA Update on the Municipal Class Environment Assessment (MCEA) and the Municipal Project Assessment Process (MPAP)

The MEA and the Ministry of the Environment, Conservation & Parks (MECP) have been discussing environmental assessment (EA) reform since 2016, with the intention of ultimately streamlining the MEA's Municipal Class Environmental Assessment (MCEA).

Until such time that the MECP revokes the MCEA and replaces it with the MPAP regulation, the February 2024 MCEA version remains in effect. In the meantime, municipalities must continue using the current MCEA process while the MEA prepares for the potential transition to MPAP.
