Upcoming Revisions to OPSDs Following Changes to Ontario Electrical Safety Code

In May 2025, the Ontario Electrical Safety Code was revised through Bulletin 2-12-15 - Traffic Signal Systems. Enforcement begins in November 2025, rendering approximately six Ontario Provincial Standard Drawings (OPSDs) out of compliance.

To address this, the OPS Electrical Committee is preparing revisions for the Fall 2025 OPS update. In the interim, the MTO is developing Ministry Temporary Ontario Drawings (MTODs) as a temporary solution.

Once issued, the MTODs will replace the affected OPSDs until revised versions are officially published. The temporary use period is expected to last about four months.

More information will be provided once the MTODs are available.

- When municipalities and project leaders must file notices under the regulation
- How to use and navigate RPRA's Excess Soil Registry, including how to file a notice
- Support and resources to help with using the registry

Nominations for MEA- Board of Directors

Are you interested in helping the MEA shape municipal engineering in Ontario? You can contribute by serving on the MEA's Board of Directors. The MEA Nominating Committee is currently addressing how many vacancies will exist at the end of the current Board term and will be searching for eligible candidates to fill these spots. To be considered by the MEA's Nominating Committee for election to the MEA Board of Director at the 2025 AGM on November 13, 2025, Section 6.04 of the MEA Constitution/By-Law specifically states the following:

Additional candidates for the vacant positions on the Board may be nominated but such additional candidates must be Voting Members (excluding Life Members) nominated by their fellow Voting Members. Such nominations shall be submitted in writing to the Executive Director, comprised of the signatures of five (5) other Voting Members, representing five (5) separate municipalities, at least seventy-five (75) days prior to the Annual Meeting of the Members. Such nomination and sponsorship must be in writing and filed with such officer as the Board shall direct and within the time period therein prescribed. In the event the Nominating person is a Life Member and is retired, the requirement that a Nominator represent a municipality is waived.

Nominations **must** follow the above requirements to be considered eligible. **The deadline to submit nominations for the 2025/2026 Board term is midnight, Friday August 29, 2025** (at least 75 days prior to the AGM). Please submit nominations to <u>adminemunicipalengineers.on.ca</u>

MCEA REFORM


The Minister of the Environment, Conservation and Parks has recently advised the MEA that the Provinicial Government is moving forward with legislation to revoke the current Municipal Class EA and replace it with a new regulation (Municipal Project Assessment Process - MPAP. While do not have a firm schedule, we expect this to occur sometime later this summer or early autumn.

MCEA USER GUIDE

While the MECP is planning to revoke the MCEA, until the new MPAP Regulation is approved, the current MCEA process still applies. The MEA continues to offer its MCEA User Guide (September 2023) publication for proponents. It is currently available for purchase in hard copy format only.

UPDATES FROM OPS SPECIALTY COMMITTEES

OPS Electrical Committee- An update to the Canadian Electrical Safety Code could impact electrical standards. The committee will be conducting a full review of any potentially affected specifications and drawings.

OPS Environmental Committee is currently reviewing OPSS.MUNI 803, 804 and 805 with a publication target for November 2025.

OPS Watermains Committee is currently reviewing and updating several OPSDs in the 704 and 705 series. The Committee is also working on OPSS.MUNI 1853.
