#### The Opportunity

Reporting directly to the General Manager – Finance & Infrastructure Services, this role is responsible for leading a team of professional/technical staff, coordinating activities within the department and other internal departments, managing and liaising with consultants and external agencies for the successful delivery of stormwater management activities including a system wide Environmental Compliance Approval (ECA) for the Town, authorized by the Ministry of the Environment, Conservation and Parks (MECP). Also, this position is responsible for the development and maintenance of stormwater assets and their corresponding programs including retrofitting and cleaning stormwater management facilities, erosion restoration studies, watercourse assessment and monitoring. As Manager, Stormwater, you will perform the following duties, including but not limited to:

- Update and manage the Town's Stormwater Master Plan / Asset Management Plan for stormwater assets, influencing the 10 Year Capital Plan and good Asset Management principles as per applicable legislation
- Undertake and manage Class Environmental Assessment studies related to stormwater and drainage producing detailed designs to tender ready construction packages
- Prepare request for proposals (RFP) and tender documents to retain consultants and contractors for various drainage studies, municipal drains, and maintenance and construction activities to deliver on an annual capital program of \$2 million per year
- Respond to flooding/drainage complaints from the public, road operations and capital staff with a customer centered focus on results in the short and long term

Through demonstration of strong leadership, interpersonal, analytical, and problem-solving skills the Manager, Stormwater will provide leadership to staff within the division, participate in recruitment, and performance management.

### The Ideal Candidate

A Masters-Degree in the fields noted is considered an asset. Accreditation as a Registered/Licensed as a C.E.T., L.E.T. or P.Eng. with OACETT/PEO or eligibility to acquire within 1 year of hire is required. Certification as an Ontario Drainage Superintendent would be considered an asset. Our ideal candidate has a minimum of 7-10 years related experience in stormwater management or water resources engineering.
