- Responsible for contract management, permit applications, and any other necessary approvals.
- Provides technical and regulatory requirement support to the Bridge Maintenance Supervisor and crews.
- Using an evidence-based risk management approach takes lead in the development, maintenance, and improvement of the Asset Management Plan related to bridge infrastructure. Includes recommended optimal rehabilitation, repair, replacement schedules for bridges and large culverts and the required funding.
