- Ensure compliance with all legislation and liaise with the Ministry of Environment, Conservation and Parks (MOECP) and other regulatory bodies.
- Act as ORO (Overall Responsible Operator) as required.

Regulatory & Technical Oversight

- Prepare and submit all required reports, data, and permits to meet provincial and federal legislation.
- Maintain Environmental Compliance Approvals and Quality Management documentation.
- Respond to emergencies, spills, and operational issues to ensure continuity of service.

People & Financial Management

- Supervise unionized and non-union staff, including hiring, training, performance evaluation and development.
- Develop and manage operational and capital budgets.
- Oversee contracts, work orders and contractor performance.

Collaboration & Public Service

- Investigate and respond to public and internal inquiries.
- Liaise with staff, Council, consultants, and the community on wastewater system matters.
- Prepare reports and presentations for Council and Committees as required.

- MOECP Class IV Wastewater Treatment License and Class III Wastewater Treatment Collective License.
