- Proven experience reviewing or managing development applications under the Planning Act.
- Strong technical knowledge in multimodal transportation design, traffic operations, and land use planning.
- Working knowledge of applicable legislation and standards, including:

 - *TAC and OTM manuals, NPC-300 Environmental Noise Guidelines, Ontario Bikeway Design Guidelines, OPSS/OPSD*

- Strong interpersonal and communication skills, with the ability to resolve issues, lead meetings, and represent the City effectively with internal and external stakeholders.
